SUBJECT: OPERATING ENGINEERS 2022-2025
MASTER INSPECTION, FIELD SOILS AND MATERIAL TESTING AGREEMENT

Effective October 1, 2023, in accordance with the Operating Engineers Local 12 2022-2025 Master Inspection, Field Soils and Material Testing Agreement, there will be \$4.00 increase to be allocated as follows:

Wages	\$2.00
Health & Welfare.....	\$0.50
Pension.....	\$0.50
Defined contribution Plan.....	\$1.00

New rates for all fringe benefits are as follows:

*Vacation/Supplemental Dues are added to the hourly wage rate to establish the gross pay for tax purposes. This gross amount is subject to normal payroll deductions. After normal deductions, the full Vacation/Supplemental dues contribution is deducted, reported and paid to the appropriate Trust Fund.

****Please Note**** Due to a reallocation of monies, **effective October 1, 2023**, the Vacation-Holiday amount of Two Dollars and fifteen cents (\$2.15) will be increased ten cents (10¢) to Two Dollars and twenty-five cents (\$2.25) and the Supplemental Dues amount of One Dollar and seventy cents (\$1.70) will be decreased ten cents (10¢) to One Dollar and sixty cents (\$1.60). The total Vacation-Holiday contribution amount of Three Dollars and eighty-five cents (\$3.85) will remain the same, for all hours worked and paid.

Effective August 1, 2007, it was agreed in negotiations that any employee at a jobsite or project who is designated by the Employer in writing, the responsibility of directing or coordinating the duties of other employees on the jobsite or project, shall be an employee covered by this Agreement and shall receive Two Dollars (\$2.00) per hour above his regular rate.

0-1000	Hours - Step	I	@60%
1000-2000	Hours - Step	II	@65%
2000-3000	Hours - Step	III	@70%
3000-4000	Hours - Step	IV	@75%
4000-5000	Hours - Step	V	@80%
5000-6000	Hours - Step	VI	@90%

All shift pay or premiums required to be paid under the terms of this agreement shall be paid in full and added to the Apprenticeship Base Wage Rate, for all hours worked or paid.

At no time shall the above apprenticeship wage rates exceed any of the Journeyman Group Rates of this agreement.
