Effective July 1, 2024, in accordance with the Laborers' Master Horizontal Directional Drilling Agreement, there will be a \$3.30 increase to be allocated as follows:

After normal deductions, the full Vacation/Supplemental dues contribution is deducted, reported and paid to the appropriate Trust Fund.

APPRENTICES

Apprentice wages shall be paid pursuant to the wage schedule set forth below and contained in the Apprenticeship Standards of the Joint Apprenticeship Committee, which is based on the following percentages of the Group V journeyman rate in the Southern California Master Labor Agreement of \$46.88

Wage Rates

1st Period	1-500 hours	50%	\$23.44
2nd Period	501-1000 hours	55%	\$25.78
3rd Period	1001-1500 hours	60%	\$28.13
4th Period	1501-2000 hours	70%	\$32.82
5th Period	2001-2500 hours	80%	\$37.50
6th Period	2501-3000 hours	85%	\$39.85

The contractor shall pay to the Laborers Trust Funds the sum designated below for each hour worked or paid for on all Apprentices based on the Southern California Master Labor Agreement.

Under the terms of the 2022-2026 MEMORANDUM OF AGREEMENT RE: LABORERS MASTER HORIZONTAL DIRECTIONAL DRILLING AGREEMENT (TRAVEL TIME), the July 1, 2024, travel time hourly rates have been modified as follows:

TRAVEL TIME HOURLY RATES

The following hourly wage rates shall apply to the following classifications for travel time covered by this Memorandum of Agreement.

Group 1	\$30.23
Group 2	\$30.34
Group 3	\$31.57
Group 4	\$32.91

All Travel Time Hours will be paid at one and one-half (1½) times the Travel Time Hourly Rates. Full Trust Fund contributions are due on all Travel Time Hourly Rates.
